

Title I School-Level Parent and Family Engagement Policy South Junior High 2023-2024



At South Junior High school our mission is to provide a safe and secure environment that promotes a positive school experience. Our goal is to offer a standards-based, best-practices curriculum that allows all students an opportunity to achieve academically as well as to grow socially and emotionally. We believe in the importance of all stakeholders working collectively to maximize individual success.

With approval from the local governing board, South Junior High School has jointly developed with, and distributed to, parents and family members of participating children a written parent and family engagement policy, agreed upon by such parents, and updated periodically to meet the changing needs of parents and the school. (EC Section 11503; 20 United States Code [U.S.C.] Section [§] 6318[b][1-4]) South Junior High School's parent representatives on the School Site Council are involved in reviewing and adopting the Parent and Family Engagement Policy. As they are selected by their fellow parents, these representatives act on their behalf to ensure that the document is representative of what South Junior High School offers and if any amendments need to be made. The Parent and Family Engagement Policy that is officially adopted at a School Site Council Meeting is made available to all stakeholders via the school website, in both English and Spanish.

Part I: Involvement of Parents in the Title I Program

- Meetings are held at a variety of times and, if possible, in connection with other events occurring at the school.
- Provide virtual workshops for parents who cannot attend targeted workshops in person.
- Site Council Meetings are held monthly immediately after school.
- English Learner Advisory Committee (ELAC) and Parent Teacher Student Association (PTSA) meetings are held in the evening or late afternoon.
- Coffee with the Principal meetings are held in the mornings.
- Parent Learning Walks are held in the mornings.
- Various parent workshops (7th Grade Family Showcase, Parent Leadership Academy, etc.) are held in the evenings.
- Childcare will be provided during meetings for parents when possible.
- c) The school involves parents in an organized, ongoing, and timely way, in the planning, review, and improvement of the school's Title I program, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the school-wide program plan.  - The School Site Council meets monthly for planning, review and improve the school's Title I programs.

 - Monthly ELAC meetings for additional inputs of policy.

 - ii. A description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging state academic standards. (20 U.S.C. § 6318[c][4][B])

Part II: Building Capacity for Involvement
